

**The Division of EMS Research Knowledge Translation Grant** is awarded to help defray the costs of disseminating original research, for example as an oral or poster presentation at a research-based conference, publication, public engagement, other presentation.

## **GRANT AMOUNT:**

A maximum of CAD\$3,000.00 is available every six (6) months, for a total of \$6,000 annually for this grant. Therefore, from April 1-October 31, there is \$3,000 available, and \$3,000 for the November 1-March 31 time period. In cases where multiple applicants are successful at the same time, the total available funds will be divided equally among applicants, to a maximum of three (3) (i.e. two (2) bursaries of CAD\$3,000.00 each or three (3) bursaries of CAD\$2,000.00 each). Funds will be disbursed after receipts are submitted.

## **ELIGIBLE CANDIDATES:**

The applicant must be a principal investigator (PI) or co-investigator on the project and be selected to present the project at the meeting/conference. The applicant or their research supervisor must either reside in Nova Scotia or be actively affiliated with Dalhousie. Any multi-centre projects must include Nova Scotian co-investigators.

This Grant will only be awarded once for a given study. The committee will be the sole arbiter to what constitutes a single study.

An applicant can only be awarded one grant per fiscal year.

All project teams are also reminded to incorporate KT into their initial project planning and budget, and to seek diverse sources of funding for their KT (eg graduate studies, Faculty of Medicine, other).

#### **SCORING CRITERIA:**

Applicants will be judged on the following criteria:

- 1) Original scientific research
- 2) Relevance to EMS or the prehospital medicine field
- 3) Relevance and significance to Nova Scotia
- 4) Impact and appropriateness of KT strategy

#### **ELIGIBLE EXPENSES:**

- 1) The cost of printing the poster at Dalhousie University (if poster is printed outside the University, an amount no more than the cost of producing the poster at Dalhousie will be reimbursed)
- 2) The cost of Early Bird Registration to the conference
- 3) Travel (refer to University policies: <u>https://www.dal.ca/dept/financial-</u> services/policies/Travel-and-entertainment.html)
- 4) Meals (refer to University policies: <u>https://www.dal.ca/dept/financial-</u> services/policies/Travel-and-entertainment.html)



5) Accommodations

Expenses will be reimbursed after the event, upon submission of a typed expense claim form.

# **APPLICATION MATERIALS:**

- Completed KT Grant Application
- Cover letter summarizing the KT strategy eg. meeting, conference dates, and type of presentation (i.e. oral, poster, public presentation, etc)
- Copy of the abstract submission/summary of project findings
- Confirmation of acceptance (may be submitted later if not received by grant deadline)

\* If a Confirmation of Acceptance is not available by submission deadline, please state this in the <u>cover letter</u>. The application will be reviewed and if successful, final confirmation and money disbursement will only occur when Confirmation of Acceptance is forwarded.
